Armed Conflict between the AFP and BIFF (IS-inspired group) in Maguindanao

INCIDENT BACKGROUND

On 09 November 2019, the Armed Forces of the Philippines (AFP) launched mortar shelling against an Islamic State-sympathizing faction of the Bangsamoro Islamic Freedom Fighters (BIFF) in Sitio Guguko, Tukanalipao, Mamasapano municipality in the province of Maguindanao. This led to armed hostilities between the two parties, triggering displacement of the local population and an undetermined number of casualties, including a civilian who was injured by stray bullets.

On 22 November 2019, government forces stationed at Barangay Meta, in the municipality of Datu Unsay, Maguindanao province were reportedly attacked by BIFF members. This resulted in continued military operations against the BIFF in Barangay Pusao, Shariff Saydona Mustapha, Maguindanao, which escalated and spread to the nearby municipalities of Datu Saudi Ampatuan, Shariff Aguak, and Talayan, all in Maguindanao.

CURRENT SITUATION

A total of 7,883 families (39,186individuals) have been displaced in five municipalities within and outside the SPSM box, i.e. Sharif Saydona Mustapha, Shariff Aguak, Datu Saudi Ampatuan, Mamasapano and Talayan. As of this report, the IDPs are staying in 20 evacuation sites in different locations, while others sought refuge with their relatives.

IDPs are in need of humanitarian assistance, as they have experienced repeated displacement during this year with limited government assistance. Some are also experiencing health issues. Children in affected communities have stopped going to school while the military operations are ongoing.

Livelihood has also been affected, with some livestock (20 cows and 3 goats, according to IDPs interviewed) reportedly hit by stray bullets and killed. Other pressing needs identified are drinking water, hygiene and sanitation facilities, basic non-food items for daily use, and tarpaulins for temporary shelter that can withstand harsh weather. IDPs further expressed their appeal to the parties to the conflict to spare civilian properties, and to identify lasting solutions to the fighting in order to resolve the recurring cycle of displacement.

Threat to liberty and freedom of movement		
The high mobility of the armed group has resulted in movement restrictions, because civilians (including both the host population and the IDPs) are afraid of being caught in the crossfire. Shelter		
Some of the IDPs in Barangay Datu Kilay, Shariff Saydona Mustapha have built makeshift shelters and are experiencing difficulties whenever there is heavy rainfall. Although they have tarpaulins to use, these are getting dilapidated and are generally inadequate to protect them from heat.		Continue monitoring the shelter needs of the IDPs in different displacement sites and refer to relevant agencies.
Other IDPs in Barangay East Libutan, Shariff Saydona Mustapha built makeshift shelters inside a coconut plantation, and are likewise affected by flooding due to heavy rainfall. Stagnant water due to floods have raised concerns as it is breeding ground for mosquitoes.		
Food aid, nutrition and non-food items		
Regular food rations and provision of non-food items are the pressing needs of the IDPs because they left behind their household belongings and kitchen utensils when they fled during the height of the conflict.	The Provincial Social Welfare and Development Office (PSWDO) of Maguindanao has requested the Ministry of Social Services and Development (MSSD) — BARMM for augmentation of resources in order to provide immediate food assistance and non-food items (NFIs).	Follow up with MSSD and continue monitoring the IDPs' situation.
	On 30 November 2019, the LGU-Shariff Aguak distributed food packs consisting of 5 kilos of rice, can goods, coffee and noodles to each displaced family.	
	On 27 November 2019, LGU-Datu Saudi Ampatuan distributed 5 kilos of rice to each displaced family.	
Water and sanitation		
No toilets, washing and bathing facilities had been constructed for the IDPs in evacuation sites in all the locations affected. Those who are home-based are using the WASH facilities of the host families.	The host LGUs now provide regular water rations to the IDPs. IDPs are exposed to unsanitary environments because makeshift shelters were built in low-lying areas. They are also in need of hygiene kits.		
Health		
Children, elderly persons, and IDPs with health- related issues are in need of medical assistance for common illness such as flu, fever, diarrhoea, and cough.		The issue has been referred to a NGO partner (Oxfam) for possible assistance.
		Referrals and follow-ups should also be done to the local Rural Health Unit (RHU) or Integrated Provincial Health Office (IPHO).
Education		
IDP children have stopped attending school while they are still displaced.		Refer to the Ministry of Basic, Higher, and Technical Education and/or to non-government education actors for assistance with temporary learning facilities or alternative learning systems in the IDPs' current locations.
Land and Property		
An undetermined amount of properties have reportedly been taken by unidentified parties when the fighting and displacement occurred.	IDPs have reported their losses to local authorities and requested assistance.	Continue monitoring the situation and refer to other humanitarian partners for possible provision of livelihood interventions, particularly after IDPs return to their places of origin.
20 heads of cows and 3 heads of goats owned by the IDPs were reportedly killed during the skirmish. IDPs stressed that they need compensation or some form of assistance to ensure continuity of their livelihood activities upon return.		5. g

The Protection Cluster

In the Philippines, the protection duster has been established by the National Disaster Coordinating Council (NDCC) Circular No.5 series of 10 May 2007 (Institutionalizing Cluster Approach in Philippine Disaster System). Given the fact that Mindanao did not witness major emergencies since Marawi siege, the protection cluster was not convened since mid-2017. Instead a protection working group was established in April 2019 to attend to protection needs of displaced families in BARMM

Protection Working Group for Bangsamoro Autonomous region in Muslim Mindanao (BARMM)

In April 2019, PWG for B ARMM was established under the leadership of Ministry of Social Services, co-led by UNHCR. The Protection Working Group (PWG), based in Cotabato City, is being convened to support the provision of protection interventions and services to these disaster- and conflict-affected communities. The main objectives of BARMM PWG is to strengthen coordination among relevant actors with a protection role (from region all down to municipal and community level) in order to: (a) ensure timely prevention of and response to protection issues in the BARMM region; and (b) facilitate timely information-sharing among these actors, in support of effective planning and implementation. The PWG meets every 2 months with members of Government agencies with protection roles, Relevant LGUs, UN agencies, Local and international NGOs& CSOs.


