

INCIDENT BACKGROUND

On 11 October 2020, continuous downpour brought about by Typhoon Ofel resulted in torrential flooding in Datu Piang Municipality affecting 16 barangays - Poblacion, Reina Regente, Kanguan, Damalanas, Magaslong, Buayan, Balanaken, Alonganen, Liong, Masigay, Kalipapa, Duaminanga, Balong, Montay, Dado and Ambadao.

On 20 October 2020, sudden increase of water level was noticed due to heavy rainfall. Many houses are reportedly submerged and damaged because of the flood.

CURRENT SITUATION

According to DRRMO of Datu Piang Municipality, a total of 8,369 families have been affected but are still staying in their respective homes and relatives, except for the four families from Barangay Reina Regente who evacuated to Barangay Poblacion because their houses are located along the river and their houses were completely devastated by the massive flooding.

The Local Government Unit (LGU) is preparing to distribute Family Relief Packs and 10 kilograms of rice to be provided to the affected families.

The DRRMO mentioned three hazards in their municipality, to wit: 1) COVID - 19 pandemic; 2) huge volume of water hyacinth which clogged the bridges; and 3) massive flooding across 16 barangays.

Flooding is not new to the residents of Datu Piang. They usually expect it during rainy season since Datu Piang rivers and marshlands are considered as catch basin of various rivers coming from Bukidnon and North Cotabato provinces.

1.	There is no massive displacement and majority of families just stayed in their habitual residences. However, should the water levels continue to increase and remain for a longer period, affected families may live in an IDP-like situation - inadequate food, hampered livelihood activities and no WASH facilities since their water sources and latrines are submerged.	There is an identified target evacuation center where affected families can seek refuge should the situation worsens.	MDRRMO is still requesting the Ministry of Public Works of BARMM to send heavy equipment like amphibious excavator to remove the water hyacinths under the Datu Piang Bridge which clog the flow of water. Said clogging adds up to the increase of water level in the municipality.

Protection	Clogging of water hyacinths under the Datu Piang bridge obstructing the flow of water is one the main factors of the sudden rise of water level in the municipality.
Food	Insufficient food assistance received by the affected families, specifically those displaced families from Reina Regente.
Shelter	Some houses were totally and partially damaged by the flood.
WASH	Provision of WASH facilities and hygiene kits.
EDUCATION	Provision of school supplies as needed for children's blended learning.
HLP	Financial assistance for damaged houses.
HEALTH	For those who seek refuge in temporary evacuation sites, they are in need of enough space to prevent possible transfer of communicable diseases and COVID-19.

IDP ASSESSMENT REPORT

The IDP Protection Assessment Form aims to provide a starting point for information and analysis that can help humanitarian agencies, policy makers and other stakeholders concerning instances of forced displacement or solutions (repatriation, resettlement, integration). The number of people displaced/affected may differ from the number in need of humanitarian assistance. To the extent possible, the terminology used in the Dashboard reflects the *UN Guiding Principles on Internal Displacement* and other sources of international law and practice. The information reported in the IDP Protection Assessment Forms has been received from members of the Protection Cluster across Mindanao. Consequently, unreported cases of forced displacement and solutions are not reflected. Updates will be provided as and when more information is received from members. Although efforts are made to verify the data, the Protection Cluster takes no responsibility for the incompleteness or inaccuracy of the information. At the end of every month, this data is compiled and distributed through the 'Protection Dashboard'. The information provided in this IDP Assessment Report does not necessarily reflect the views of UNHCR or any individual member of the Protection Cluster.

MINDANAO VIRTUAL PROTECTION COORDINATION PLATFORM (MVPCP)

In the present circumstances where no limited physical access to IDPs is possible, and humanitarian actors are adjusting response using alternative modalities to access people in need including relying on social media, phones and other online communication tools to maintain regular communication with protection monitors within IDP community, as well as host communities, Mindanao Virtual Protection Coordination Platform (MVPCP) will strengthen coordination among relevant actors with a protection role (from regional and provincial down to municipal and community level) in Mindanao

Under the leadership of Ministry of Social Services and Development (MSSD) and with full participation of key state agencies: DSWD, BARMM READI and IATF, members of MVPCP will work closely to ensure that COVID-19 related prevention and response initiatives at the national level include IDPs, while at the same time closely monitoring their application to ensure that IDPs have access to basic services. Members of the MVPCP will work closely to ensure timely prevention of and response to protection issues in Mindanao including BARMM region and facilitate timely information-sharing with the IDP community on health measures in response to COVID-19.

WORKING IN PARTNERSHIP

UNHCR works in partnership with government entities, INGOs, NGOs, CSOs, and UN Agencies, and other organizations. Its primary role is to share information on protection risks and needs and to facilitate coordinated intervention among the various actors involved in IDP protection. UNHCR has project partnership with CFSI, CHR, ACCORD, MMI, KI, TKI, ACTED and IRDT covering Mindanao island including BARMM region.
